As our community continues to grow, we have experienced an increase in calls for service, complex cases, new training mandates, and other external factors we cannot control. To address this, we are proud to announce the hiring of two new officers. This addition to our team will enhance our capacity to deliver quality services and uphold our commitment to community safety.

Throughout the year, our officers have taken a proactive approach to traffic enforcement and crime prevention, which has resulted in a decrease in traffic crashes, most notably, no fatalities and violent crime offenses. These events strengthen community ties and provide opportunities for discussion and collaboration.





RE: ILACP Use of Force Certification

Dear Chief Meyer:

On behalf of the Illinois Association of Chiefs of Police (ILACP), which manages the Illinois Law Enforcement Accreditation Program (ILEAP), this letter certifies that the Minooka Police Department meets the ILACP use of force eligibility requirements, set forth by the Illinois Association of Chiefs of Police.

Following our review, we have determined that the Minooka Police Department meets the conditions for certification in that the use of force policy has been reviewed and determined to comply with state and federal laws, the United Nations document on less lethal technology, as well as SAFE-T Act provisions. Force provisions center around Graham vs. Connor, deadly force, rendering aid after force, the duty to intervene, review of force incidents, taser application, and the prohibition on chokeholds unless deadly force is authorized.

Accordingly, the Illinois Association of Chiefs of Police will include your agency going forward within our database of use of force certified law enforcement agencies. This certification is active for three years beginning with the date on this letter. Congratulations on achieving this certification. 


